The Board of Supervisors met at 9:30am January 18, 2021 with Vick, Ashbacher, Vermace, and Langreck in person; and Beard present electronically.

Lee Bjerke, County Engineer, met with the Board to discuss road matters.

Mike Meirik, Spectrum Industries, met with the Board to present a funding request.

Moved by Vermace and seconded by Vick to approve Barb Schroeder, Conservation Director, and Stephanie Fromm (at-large member), Winneshiek County Development & Tourism, as the County's representatives to the Transportation Enhancement Committee. Motion carried unanimously.

Paul Berland, NEIA RC&D, met with the Board to present a funding request and to review documents related to Upper Iowa River Flood Reduction program projects. Moved by Vermace and seconded by Langreck to approve the intent to obligate funds and the affirmation of duplication of benefits for six projects as three bid packets for the program. Motion carried unanimously.
