1. That each owner and each person in the possession or control of any lands in Winneshiek County shall properly spray, cut, burn, or otherwise destroy or control all noxious weeds thereon, as defined in this chapter, at such time

blooming or coming to maturity, and shall keep said lands free from such growth of any other weeds as shall render the streets or highways adjoining said land unsafe for public travel. Noxious weeds shall be cut or otherwise destroyed or controlled on or before the following dates and as often thereafter as it is necessary to prevent seed production:
