#### City of Fort Atkinson Annual Audit

#### CITY OF FORT ATKINSON ANNUAL AUDIT

Rachelle K. Thompson, CPA today released an agreed-upon procedures report on the City of Fort Atkinson, lowa for the period July 1, 2023 through June 30, 2024. The agreed-upon procedures engagement was performed pursuant to

Chapter 11.6 of the Code of Iowa.

There were two findings reported related to the receipt and disbursement of taxpayer funds. They are found on page 5 of this report. The findings address issues such as a lack of segregation of duties and separately maintained records. Recommendations are also provided to address each of the findings.

One of the findings discussed above is repeated from the prior year. The City Council has a fiduciary responsibility to provide oversight of the City's operations and financial transactions. Oversight is typically defined as the "watchful and responsible care" a governing body exercises in its fiduciary capacity.
