If said persons do not ask for a hearing or exercise their right to reclaim the vehicle within the ten-day reclaiming period, the owner(s), lienholder(s), and claimant(s) shall no longer have any right, title, claim, or interest in or to the vehicle. A court in any case in law or equity shall not recognize any right, title, claim, or interest of the owner(s), lienholder(s), or claimant(s) after the expiration of the ten-day reclaiming period.
