Lee Bjerke, County Engineer, met with the Board to discuss road mat-

Langreck reviewed an email from Bethany Jordan regarding grant opportunities for Courthouse repairs. Moved by Vermace and seconded by Beard to authorize Jordan to apply for the HRDP grant on the County's behalf if the County is not awarded the Rural Heritage Revitalization Grant. Motion carried unanimously.

Steve Johnson and David Wadsworth, Historic Preservation Commission, met with the Board to review the report that the Smith Building is eligible for Nation Registry nomination.
